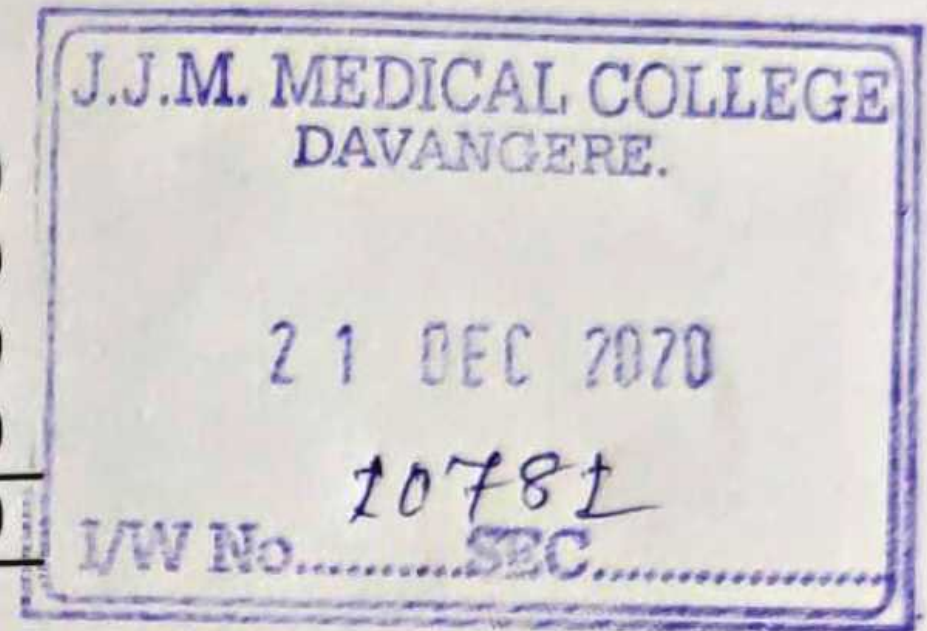

DECLARATION BY THE BOARDER

1. I hereby agree, if admitted, to confirm to the rules regulations at present in force or that may hereafter be made by the management for admission to the institute that will interfere with its orderly management and discipline as long as I am a boarder of the Hostel. I further agree to make good when called upon to do so, any damage to furniture, Electrical fittings and other articles which may be caused by carelessness, negligence or wantonness on my part.
2. I will not indulge in any kind of ragging or teasing of students.
3. I understand that I am liable for removal from the Hostel/Institution for indiscipline, or misconduct inside the Hostel.
4. I will not involve in the use of any intoxicating material in the hostel premises and create unhealthy atmosphere in that state or drunken condition.
5. I will abide by the Hostel Rules.

HOSTEL RULES

In addition of the instructions prescribed in the application form for admission, the following Instructions have to be strictly adhered to.

1. Four pass port size photos of candidate & 3 each of parent to be produced at the time of admission to hostel.
2. Rooms once allotted will not be changed except on special circumstances.
3. Students are advised to lock the rooms /lockers etc., whenever they go out
4. Students shall not keep valuables i.e. Gold etc., and heavy cash in the rooms to avoid loss, theft.
5. It is advisable to use mosquito curtains to avoid mosquito menace.
6. No outside student/friends is permitted to stay in the rooms. This is strictly prohibited and such cases will be viewed seriously.
7. Using of heaters in the rooms for boiling water, milk etc., cooking in the room is strictly prohibited. If need be, cooking can be done in the pantry.
8. Playing of cards in the rooms/premises is strictly prohibited.
9. Playing Radios, Tape recorder and CD music system should be avoided during study hours. Other hours volume should be low. It should not cause disturbance to the neighbors.
10. Boarders must take food and tiffin as per timings notified by the concerned warden from the mess only. Mess reduction will be allowed during vacation only.
11. Must maintain silence and discipline in the dining hall.
12. Smoking, consumption of Alcohol in the dining / TV hall, keeping narcotic is strictly prohibited.
13. Hostel mess charges etc., will be collected at the hostel office during the working hours as notified by the Warden.
14. Do not waste food / water.

15. Supplying / taking of food to the rooms is strictly prohibited.
16. Boarders must take proper care of the furniture supplied to them. Damages if any caused are liable to be assessed and recovered from the concerned.
17. Sticking of indecent and ugly scenaries / posters in the rooms is strictly prohibited.
18. Health disorders should be reported immediately to th doctors, as notified in notice board and to the warden or in the Hostel office.
19. News papers / periodicals etc., should not be misused.
20. Boarders are advised not to leave the hostel unauthorisely on any ground.
21. The above instructions are in the interest of the Boarders and violation by any boarder will be referred to the disciplinary committee for necessary action.
22. When the student wants to go on leave to their country, they have to obtain leave India Certificate from the concerned authorities (Superintendent of Police, Davangere District, Davangere) and also to inform College principal & Hostel warden.

JUNIOR STUDENT. IT WILL ALSO INVOLVE ASKING THE STUDENTS TO DO
ANY ACT OR PERFORM SOMETHING WHICH THE STUDENT DONT DO IN
THE ORDINARY COURSE AND WHICH HAS THE EFFECT OR CAUSING OR
GENERATING A SENSE OF SHAME OR EMBARRASSMENT SO AS TO
ADVERSELY AFFECT THE PHYSIQUE OR PSYCHE OF A JUNIOR STUDENT. IT
WILL ALSO INVOLVE INJURY TO THE BODY, WRONGFUL CONFINEMENT,
USE OF CRIMINAL FORCE ASSAULT AS WELL AS SEXUAL OFFENCES”.
