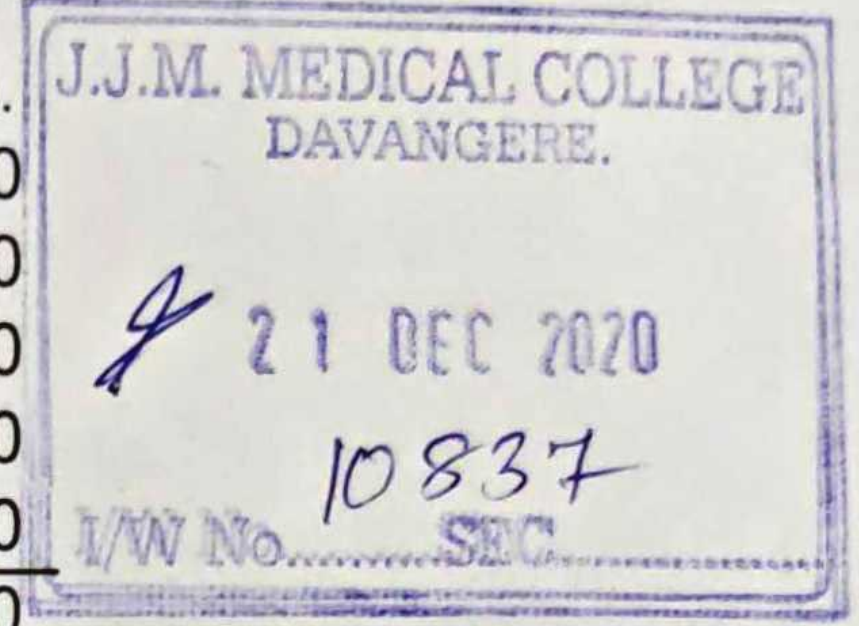



3. Refund of the deposit will be paid after sanction only after clearing all the dues of the Hostel and vacating procedure. Adjustment of Hostel arrears with the deposit is not admissible.

HOSTEL RULES

The following Instructions have to be strictly adhered to:

1. Rooms once allotted will not be changed.
2. Students are advised to use their own sturdy locks and keys to rooms/lockers etc., Whenever they go out key's should not be made available for others whenever they go to bed the room should be bolted from inside Room should be get cleaned in your presence.
3. Students should not keep valuables and heavy cash in the rooms. The administration is not responsible for loss.
4. No tube Lights or bulbs will be supplied from the hostel office. They must use their own tube light in their rooms.
5. It is advisable to use mosquito curtains to avoid mosquito menace.
6. **No outside student/friends is permitted to stay in the rooms. This is strictly prohibited and such cases will be viewed seriously.**
7. Using of heaters in the rooms for boiling water, milk etc., is strictly prohibited. If need be, heating of milk etc., can done in the Hostel mess.
8. Tube lights fixed in the bath rooms, Toilets and corridors should not be misused.
9. Playing of cards in the rooms/premises is strictly prohibited.
10. Playing Radios, HI-FI systems and Tape records should be avoided during study hours. when played should be in low tone.
11. Boarders must take Food and tiffin as per timing notified by the concerned Warden. **No out side food is allowed in side the hostel. Food charges will be levied even though not taken food during the month.**
12. Must maintain silence and discipline in the dining hall.
13. Smoking in the dining hall is strictly prohibited.
14. The mess charges will be on dividing / contract system. Mess bill will be announced on 10th of every month. They must note that fine will be levied when boarders failed to make payment before due date. Fine will be collected as noted below.

i) From the date of announcement of mess bill to 14 days	- No Fine
ii) For next 10 days	- Rs. 50-00 or Re. 5/- day
iii) For next 5 days	- Rs. 50-00 or Rs. 10/- day
iv) Beyond the month	- Rs. 100-00
v) Fine Rs.100/- accumulating every month till the payment	
15. Mess charges will be collected at the hostel office during the working hours as notified by the Warden
16. No reduction in mess charges will be given to any Boarder unless otherwise the situation Warrants them to leave the hostel for their native places except during vocation They are eligible for reduction with the following condition.
 - i) leave less than 5 days at a time no reduction
 - ii) Reduction will not be given after 25th
 - iii) Totally not more than 15 days reduction in a month will be given. On medical grounds, this will be relaxed on production of medical certificate.
 - iv) They must apply for reduction well in advance and should take reduction slip. from the mess Supervisor before leaving the Hostel.
 - v) When the regular classes are going on reduction will not be allowed.
 - vi) Reduction will not be given during examination days.
 - vii) Any changes of Mess permission should obtain before the last week of the month.
17. Do not waste food.
18. **Supplying / taking of food to the rooms is strictly prohibited.**
19. Boarders must take proper care of the furniture supplied to them. Damages if any caused are liable to be assessed and recovered from the concerned.
20. The Boarders are not allowed to vacate the Hostel in the middle of the year.
21. Sticking of indecent and ugly scenarios / posters in the rooms is strictly prohibited.
22. Health disorders should be reported immediately to Warden or in the Hostel office.

23. News papers/periodicals etc., should not be misused.
 24. Boarders are advised not to leave the hostel unauthorisedly on any ground.
 25. **After clearing dues and vacate the room, they must do signature in the furniture register maintained in the office.**
 26. The above instructions are in the interest of the Boarders and violation by any boarder will be referred to the disciplinary committee for necessary action.

WHAT CONSTITUTES RAGGING

RAGGING CONSTITUTES ONE OR MORE OF ANY OF THE FOLLOWING ACTS :

- a. Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating, or handling with rudeness a fresher or any other student.
- b. Indulging in rowdy or indisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student ;
- c. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student ;
- d. Any act by a senior student that prevents, disrupts or disturb the regular academic activity of any other student or a fresher.
- e. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- f. Any act of financial extortion of forceful expenditure burden put on a fresher or any other student by students;
- g. Any act physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person:
- h. Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.

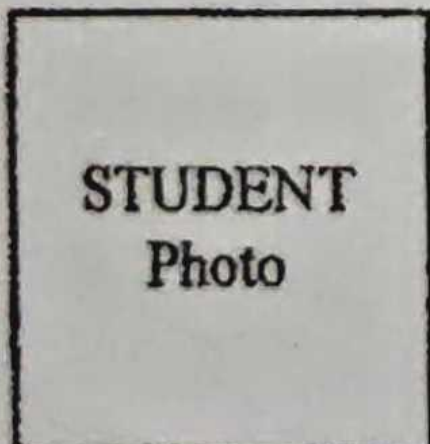
