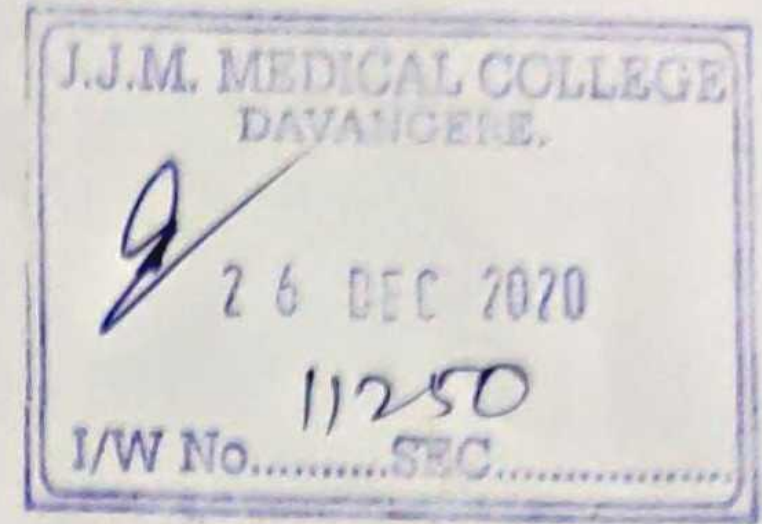

ROWDY OR UNDISCIPLINED ACTIVITIES WHICH CAUSE ANNOYANCE OR  
RAISE FEAR OR APPREHENSION IN A FRESHER OR A JUNIOR STUDENT. IT  
WILL ALSO INVOLVE ASKING THE STUDENTS TO DO ANY ACT OR  
PERFORM SOMETHING WHICH THE STUDENT DON'T DO IN THE  
ORDINARY COURSE AND WHICH HAS THE EFFECT OF CAUSING OR  
GENERATING A SENSE OF SHAME OR EMBARRASSMENT SO AS TO  
ADVERSELY AFFECT THE PHYSIQUE OR PSYCHE OF A JUNIOR STUDENT. IT  
WILL ALSO INVOLVE INJURY TO THE BODY, WRONGFUL CONFINEMENT,  
USE OF CRIMINAL FORCE ASSAULT AS WELL AS SEXUAL OFFENCES",
